Costa Accumulator Prize Draw (October 2019)

1. INTRODUCTION

- 1.1 By entering the Costa accumulator prize draw (the "**Promotion**"), all participants will be deemed to have accepted these terms and conditions in full. All entry instructions form part of these terms and conditions.
- 1.2 The Promotion is open to Costa Coffee Club members who are residents of the UK (excluding Northern Ireland) aged 18 or over at the date on which they enter the Promotion, except for employees of the promoter, its group companies, agents or anyone professionally connected with this Promotion and any member of their respective immediate families.
- 1.3 Entry to the Promotion opens at 00:01am on Tuesday 8 October 2019 and closes at 23:59pm on Thursday 31 October 2019 (the "**Promotion Period**"). Entries received after the Promotion Period will not be eligible to win a prize.

2. HOW TO ENTER THE PROMOTION AND PRIZES

- 2.1 To enter the Promotion, open the Promotion email sent from us on Monday 7 October 2019 and make the required number of purchases during the Promotion Period to be entered into the prize draws. As you complete more purchases during the Promotion Period, you will qualify to be entered into the different prize draws. - 2.2 All bonus Costa Coffee points will be added to the relevant account within 48 hours of the qualifying purchase. For example, 350 bonus points will be added within 48 hours of your 4th purchase.

3. WINNERS

- 3.1 The winners will be selected at random from all eligible entries on 7 November 2019 by computer.
- 3.1 Winners will be notified by email by 14 November 2019 and will be asked to confirm their details for delivery of the prize by logging into their Costa account to check that the address stated is correct and to update it if necessary. Any necessary updates will need to be done within the timeframe stated in the winner notification email.

4. CONDITIONS
